O R D E R

The petitioner/appellant Mr. Moinul Haque is absent without information. The BDO of Bhowanipur Development Block, Howly Sri C.R.Das, and 1st Appellate Authority is present, accompanied by (1) Sri Tapan Ch. Das, Sr. Asstt.& (2) Sri Nirmal Das, E.O and SPIO, Office of the Bhowanipur Development Block.

The second appeal petition dated 8-4-2013 is taken up for hearing ex-parte.

From a perusal of the case records, it is seen that the BDO, Bhowanipur Dev. Block informed the petitioner vide his letter dated 18-8-2012, i.e., within the stipulated period of 30 days to deposit Rs. 2082/- with detailed break-up for obtaining the required information in respect of 17 Gram Panchayats. The BDO deposed before this Commission that the required amount has not yet been deposited and the information relating to G.Ps have not yet been furnished to the petitioner.

However, the information relating to Anchalik Panchayats were received by the petitioner, as mentioned in his letter dated 8-4-2013.

The BDO Bhowanipur Dev. Block made a written submission dated 1-8-2015 which is entered into the case records. He has stated that the concerned 17 G.Ps have been asked to furnish the required information to the BDO. The Commission directs the petitioner to deposit the required cost of Rs. 2082/- with the BDO within 15 days from the date of receipt of this order, if he is still interested in getting the information.. The Commission also directs the BDO, Bhowanipur Dev. Block to furnish the required information within 15 days from the date of receipt of the cost of providing the information from the petitioner, with intimation to this Commission.

With the above order the second appeal petition is disposed of .
