**O R D E R**

The petitioner Sri Pratap Barman is present. The Public Authority is represented by Sri Sanjib Kr. Bhuyan, Director, Elementary Education, Smti Sewali Devi Sarma, ACS, Deputy Secretary, Education (Elementary Deptt), Sri Nitul Barman, Sr. Administrative Asstt, Sri Khagen Deka , Statistical Asstt. office of the Director, Elementary Education, Sri Samin Das, Head Asstt. O/O D.I of Schools, Nalbari and Sri Dhiraj Ch. Das, Research Asstt., O/O Director, Elementary Education.

The second appeal petition dated 29-4-2013 is taken up for hearing in presence of both the parties.

The petitioner vide his RTI petition dated 27-3-2012 wanted a copy of the list of more than 4,500 teachers who were appointed in Nalbari District in the year 2001, as stated by the then Hon'ble Education Minister, Assam in the State Legislative Assembly on 20<sup>th</sup> July, 2004 in reply to Starred Question No. 128.

The Director, Elementary Education has made a written submission dated 4<sup>th</sup> August, 2015, which is entered into the case record.

The Deputy Secretary, Elementary Education has also made a written submission dated 4-8-2015, which is also entered into the case record.

The D.I of Schools Nalbari has also made a separate written submission dated 4-8-2015 which is also entered into the case records.

The D.I of Schools has enclosed 1 sheet of paper, where it is stated that 341 sheets relating to appointment of OBB (7066 teachers) comprising the select list and appointment letters were received from the Head Asstt. office of the D.I of Schools, Nalbari by the Director, Elementary Education under his signature dated 11-11-2009.

The Commission directs the Director, Elementary Education to produce the select list before this Commission on 18-8-2015.

In his written submission, the Director of Elementary Education submitted that the then D.I of Schools, Nalbari appointed 4510 L.P School teachers illegally which was cancelled by the Govt. vide order dated 16<sup>th</sup> July, 2001. An enquiry was conducted by the then Addl. Deputy Commissioner, Nalbari. The Director mentioned that while the inquiry report mentions the No. 4510, there was no list containing the names of the 4510 teachers who were appointed illegally. The

Commission also directs the Director, Elementary Education to produce a copy of the Inquiry Report on the next day of hearing i.e on 18-8-2015.

The Commission also directs the petitioner also to bring his appointment letter, if any, on the next date of hearing i.e., 18-8-2015 at 11 A.M.
