O R D E R

The appellant Sri Bhargab Bora is present. The Respondent Sri N. C. Das, Deputy Director, Food & Civil Supplies and Consumer Affairs, Tezpur is present accompanied by Sri Deben Bora, Sr. Asstt. , Sonitpur.

The second appeal petition dated 17-3-2013 is taken up for hearing in presence of both the parties.

The Deputy Director present submitted that in response to the RTI application dated 11-9-2012, the required information have been furnished to Sri Bhargab Bora on 23-5-2013. Before that on 20-10-2012 the Deputy Director asked the petitioner to deposit Rs. 758/- towards the cost of photo copying the required information vide letter dated 20-10-2012. Thereafter, the appellant personally contacted the office of the Deputy Director and paid Rs. 106/- to get 53 copies of photo copied documents on 15-3-2013.

The appellant admitted that he has received the required information, but he is not satisfied with the same as he suspects that some of the information are incorrect..

The Commission, therefore, directs the Deputy Director, Food ,Civil Supplies and Consumer Affairs, Tezpur to allow the appellant Sri Bhargab Bora to inspect the original records/documents in his office within 15 days from the date of this order, which is pronounced in presence of both the parties. The appellant shall be allowed to take notes and also additional photo copies of documents required by him free of cost up to 25 copies and thereafter on payment @ Rs. 2/- per page for any additional page.

After completing the process of inspection of documents and furnishing of the correct information, the Deputy Director will inform the Commission about the action taken.

With the above order the second appeal petition dated 17-3-2013 is disposed of.
