**O R D E R**

The appellant/petitioner Shri P. Bezbaruah is absent without information. The Public Authority is represented by Shri Ramenjit Das, Senior Sub-Registrar, Kamrup (M) district. The second appeal petition dtd 04.7.12 is taken up for consideration and hearing ex-parte.

The Sr. Sub-Registrar has made a written submission dtd 4.9.15 enclosing a copy of the letter dtd 2.9.15 addressed to the appellant Shri P. Bezbaruah, which is entered into the case records. In his written submission and the letter mentioned above, the Sr. Sub-Registrar have stated that page 7 ( seven) of the Sale Deed No. 2915/2011 was not stored in the computer due to technical problem. Therefore, the order dtd 25.6.12 of the First Appellate Authority i.e. the Deputy Commissioner, Kamrup ( M) could not be complied with till date. The Sr. Sub-Registrar deposed that he has contacted the purchaser in the above mentioned Sale Deed for providing the missing page No. 7.

The Commission, therefore, directs the Sr. Sub-Registrar to furnish the page No. 7 of the Sale Deed No. 2915/2011 within 15 days from the date of receipt of this order which was pronounced in presence of the Sr. Sub-Registrar.

With this order the second appeal petition dtd. 4094.7.12 is disposed of.
