The Public Authority is represented by Dr. N. Lalsim, Addl. Director of Health Services (Hills) in the office of the Director of Health Services, Assam, Hengrabari, Guwahati-6 and Shri Gopesh Thakuria, Sr. Assistant in the office of the DHS, Assam. The petitioner Shri Premson Bey is absent without information. The second appeal petition dtd 16.8.12 is taken up for hearing ex-parte.

From perusal of the case records it is seen that the Director of Health Services, Assam vide his letter dtd 02.7.12 had furnished point-wise information to the petitioner. Being dissatisfied with the information furnished to him, he submitted a representation before the DHS on 13.7.12 stating that the information furnished to him is incomplete and incorrect. He sought certain clarification from the DHS. Having not received any response from the DHS to his prayer dtd 13.7.12, the petitioner has filed a second appeal petition before this Commission on 16.8.12. But in absence of the petitioner his grievances could not be heard and ascertained.

On perusal of the original RTI petition dtd 22.5.12 it is seen that point No. 7 involves third party information. Similarly, point No. 4 involves disclosure of the name and designation of the persons who conducted the interview. The Commission is of the view that disclosure of the identity of the interviewer/examiner is not admissible u/s 8(e) of the RTI Act.

As regards enclosures submitted by the candidate, the Addl. DHS shal seek the consent of the concerned candidates before furnishing the same to the petitioner.

As for the remaining points, the Commission directs the Addl. DHS (Hills) to allow the petitioner Shri Premson Bey to inspect the relevant office documents,

takes notes thereof and also take photocopies of any document that the petitioner may need free of charge upto 20 pages and thereafter on payment of Rs. 2.00 per additional photocopies within 30 days from the date of receipt of this order with intimation to the Commission.

With the above orders, the second appeal petition dtd 16.8.12 is disposed of.
