Seen the copy of recorded decision dated 24th August, 2015 of the Revenue & Disaster Management Authority, Govt. of Assam, which has been passed by Sri S. K. Das, ACS, Joint Secretary , Govt. of Assam and SPIO in compliance with this Commission's order dated 9-1-2015. It is also seen that copy of the said order has been furnished to the RTI applicant Sri Soumitra Sengupta and to the Chief Executive Officer of IL&FS Technologies Ltd. Vide the said order, which is a speaking order, the SPIO of the Revenue & Disaster Management Department, Govt. of Assam has declined to provide the information sought for by the applicant on grounds of involvement of third party information. The Commission is satisfied that the SPIO has complied with the provisions of Section-11 of the RTI Act and this Commission's order dated 7-1-2015.

The Commission also notes that after the Commission's order in Appeal Case No. KP(M).8/2015 which was pronounced in presence of the appellant Sri Soumitra Sengupta and the SPIO of Revenue and Disaster Management Department **yesterday**, the appellant Sri Soumitra Sengupta submitted that his requirement is satisfied by order in appeal case No. KP(M). 8/2015 and he will not like to pursue the second appeal petition in case No. KP(M).58/2013 any further.

In view of the above, this second appeal petition is also disposed of.
