O R D E R

The petitioner/ appellant Smti Devajyoti Gogoi is present along with one Sri Madhurya Chetia to assist her.

The public authority to be represented by the SPIO of APSC is absent without any information.

The complaint petition dated 26-8-2015 is taken up for hearing ex-parte of the SPIO, APSC.

The complainant filed an RTI petition before the SPIO of APSC on 26-6-2015 requesting for photo copies of her answer sheets for (1) **General Studies** (2) **General English** (3) **Political Science (paper-I & II)** and (4) **Sociology (paper-I & II)** in the Combined Competitive Main Examination, 2013. She mentioned her Roll No. as **0926784**. She also wanted to know the cut-off marks in the final results of each category (General/OBC/SC/ST/Physically Handicapped etc.). After not receiving any response from the SPIO, APSC to her RTI application, she filed a complaint petition before this Commission on 26-8-2015.

In her complaint petition she has stated that after repeated requests for the above, the RTI branch of the APSC asked for depositing Rs. 400/- as advance payment towards the cost of photo copy. She has also enclosed photo copy of receipt No.-1577865 dated 17-7-2015 as a proof of her payment of Rs. 400/- to APSC.

In view of the above, the Commission directs the SPIO of APSC to furnish the full information, as sought for by the petitioner vide her complaint petition dated 26-6-2015 within 7 days from the date of receipt of this order.

With the above order the complaint petition is disposed of.
