**O R D E R**

The petitioner Sri Raghu Nath Kalita is present. The public authority is represented by (1) Sri Kamini Kanta Kalita, Principal I/c and (2) Md. Nurul Islam Ali Ahmed, Asstt. Teacher, Jalukbari Higher Secondary school.

The appeal petition dated 3-12-2013 filed by the appellant Sri Raghu Nath Kalita is taken up for hearing in presence of both the parties.

It is seen from the records that the matter was heard by this Commission earlier on 7-10-2013 and an order was passed. But the grievances of the petitioner still remains un-resolved. The grievances of the petitioner are that (1) he took two bank loans from Pragjyotish Gaonlia Bank and another from Allahabad Bank and the monthly instalments were deducted from his salary and paid to the Bank by the School authorities. When he received his bank statement before his transfer from Jalukbari Higher Secondary school he found that 1 (one) installment each amounting to Rs. 860/- and Rs. 2190/- respectively were not paid by the School authorities to the concerned banks.

(2) The petitioner was also a member of the Jalukbari Teachers' Cooperative Society. Before his transfer he wanted to settle these amounts with the Cooperative Society. But the School authorities did not settle the accounts.

The Commission **directs the petitioner also to visit the School along with all records available with him within 15 days from the date of this order to settle this problem**

Further, the petitioner also wanted to have a copy of the Bye Laws of the Teachers' Cooperative Society of Jalukbari Higher Secondary School along with the Balance Sheet and audit report for the period from 2003-2006. He also wants a copy of the Registration Certificate of the Society.

The present Principal In-charge deposed before this Commission that the Teachers' Cooperative Society is not registered under the Assam Cooperative Societies Act or the Societies' Act of 1860. Although it is named as Teachers' Cooperative Society it is more in the nature of mutual help fund constituted by contributions made from the Teachers' and to help the teachers when they are in need.

The Commission, therefore, **directs the Principal In-charge to furnish copies of any Resolution constituting the said Teachers' Cooperative Society along with the audited reports for the period from 2003-2006.**
