O R D E R

The petitioner Sri Diganta Pegu is present along with one Sri Jamini Doley to assist him. The public authority is represented by Smti Alaka Goswami, ACS, Deputy Secretary , WPT & BC department and one Sri Diganta Talukdar, Sr. Administrative Asstt. , WPT & BC Department. The Commissioner & Secretary, WPT&BC Department submitted a written submission dated 7th September, 2015, which is entered into the case records. In his written submission , the First Appellate Authority has stated that they have already given instructions to the Mising Autonomous Council to furnish the required information to the petitioner. The First Appellate Authority also mentioned that the petitioner subsequently added additional points for securing information which were not mentioned in his original RTI application.

2. The second appeal petition dated 10-9-2013 is taken up for hearing in presence of both the parties.

3. From a perusal of the case records it is seen that the petitioner wanted to have information under three items pertaining to Mising Autonomous Council by his RTI application dated 1-4-2013. The PIO of Mising Autonomous Council replied vide his letter dated 23-5-2013.

partial. He wants to have copies of Annual Action Plans with sanction of Govt. for the for the Financial Year 2009-10, 2010-11, 2011-12, 2012-13.

7. After hearing both the parties and in view of the facts and circumstances, the Commission directs the Principal Secretary of Mising Autonomous Council to allow the petitioner to inspect the documents relating to para No 4 and. 6, above, within 15 days from the date of receipt of the order and allow him to take notes and also take photo copies of documents as he may require free of cost up to 50 pages and thereafter, on payment of Rs. 2/- for each additional copy, with intimation to the Commission.

8. Here also the information would be furnished free of cost up to 50 pages/ photo copies and thereafter on payment of Rs. 2/- for each additional copy.

9. With the above order, the second appeal petition dated 10-9-2013 is disposed of.
