O R D E R

The complainant as well as the public authority, both are absent. However, it is seen from the case records that the First Appellate Authority i.e., the Project Director, DRDA, Cachar, vide his order dated 18-1-2012 had directed the concerned G.P Secretary to furnish the required information to the petitioner within 15 days. It is also seen that the BDO of Sonai Development Block had furnished the information to the petitioner vide his letter dated 4-6-2012, receipt of which was acknowledged by the petitioner with the noting : "received documents except shown on reverse"

In the absence of the complainant it could not be ascertained as to what additional information he wants. In his complaint petition dated 18-7-2012 the complainant also mentioned about furnishing of incomplete, misleading and false information. But without hearing both the parties, the Commission could not take a view on this.

The Commission, therefore, directs the BDO of Sonai Development Block to allow the complainant Sri Kamal Hussain Laskar to inspect the relevant records and documents during office hours on any working day with 2 days advance notice, within 15 days from the date of receipt of this order. The BDO and the concerned G.P Secretary to allow the petitioner to take notes or photo copies of documents that he may need free of cost up to 25 copies and on payment of Rs.2/- for every additional copy thereafter. Both the BDO and the concerned G.P Secretary will report compliance of this order to the Commission within 30 days. If the complainant does not turn up for inspection within 15 days from the date of receipt of this order, then the BDO and the concerned G.P Secretary shall inform the Commission, accordingly.

With the above order, the Complaint petition dated 1-7-2012 and 8-11-2012 are disposed of.
