## ORDER

The complainant Sri Pratap Ch. Dutta is absent without information. The public authority is represented by Dr, Lalsim, Addl. Director, Health Services and SPIO in the office of the Director of Health Services and Sri Loknath Kalita, Sr. Asstt, Office of the DHS, Assam, Hengrabari.

The complaint petition dated 30-7-2013 is taken up for hearing ex-parte of the appellant.

The Director of Health Services has sent a written submission dated 10-9-2015 stating that the Principal of Jorhat Medical College and Hospital furnished the information in respect of Smti Padmini Saikia, Ward Nurse of Jorhat Medical College and Hospital as sought for by the RTI applicant. The DHS has admitted that through oversight his office wrote the name Smti Padmini Saikia as Smti Padumi Saikia.

The only complaint made in the complaint petition dated 30-7-2013 is that in place of Smti Padumi Saikia, DHS had given information in respect of Padmini Saikia. The DHS had already admitted the error which he has called unfortunate and he has stated that it happened due to oversight.

In view of the above, the Commission directs the SPIO in the office of DHS to immediately send a letter dated 16-9-2015 addressed to the Assam Information Commission to the complainant Sri Pratap Ch. Dutta, clarifying that the information already furnished is correct and this was in respect of Smti Padmini Saikia which was inadvertently written as Padumi Saikia , within 7 days from the date of receipt of this order.

With the above order the complaint petition is disposed of.
