O R D E R

The petitioner/appellant Sri J. Payeng is present. The public authority is represented by (1) Sri Surjya Kr. Talukdar, Superintending Engineer, PWD, Tezpur Building Circle, Tezpur and (2) Sri Bihari Lal Talukdar, Asstt. Executive Engineer (T.C), office of the Superintending Engineer, PWD, Tezpur Building Circle, Tezpur.

The second appeal petition dated 10-7-2013 is taken up for hearing in presence of both the parties.

The Superintending Engineer, PWD, Tezpur Building Circle has made a written submission dated 29-9-2015, which is entered into the case records. He has enclosed a letter dated 6-5-2013 by which the petitioner was asked to deposit an amount of Rs. 5865/- towards photo copies of the required documents. It appears that for whatever reasons the amount has not been deposited and the information has not been furnished.

On a perusal of the original RTI petition dated 17-4-2013, it appears that the information sought for is admissible under the RTI Act, 2005. The Commission, therefore, directs the SPIO in the office of Superintending Engineer, Tezpur Building Circle **to allow the petitioner to inspect the relevant documents on any working day, during office hours, within 15 days from the date of receipt of this order and allow him to take notes or photo copies of documents required by him, free of cost up to 150 copies and on payment of Rs. 2/- for every additional pages there after.**

The petitioner will also give at least 2 days notice to the SPIO in the office of Superintending Engineer, Tezpur Building Circle for inspection of documents.

With the above order the second appeal petition dated 10-7-2013 is disposed of.
