Deposing before the Commission the appellant/complainant submitted that he was yet to receive the information he had sought relating to U.C. and other specific aspects. The SPIO submitted in person that delay has occurred owing to change of incumbents and now the information sought for is available and will be supplied to the applicant immediately. The Commission orders that the documents will be provided to the applicant free of cost.

The Deputy Director, Higher Education being the First Appellate Authority has submitted that the first appeal has been disposed of by giving a direction to the SPIO to provide the required information within the time specified by the RTI Act, 2005. She further assured that direction should be repeated to all SPIOs to dispose of RTI applications promptly within the time frame prescribed by the RTI Act, 2005 and also issue directions to make relevant information available in the public domain proactively.

The Commission directs that information to be furnished to the applicant by the SPIO may be done within 10 days of the receipt of this order. The appellant/applicant will have the option to come back to the Commission, if not fully satisfied.
