ORDER

The appellant Md. Mansur Ali is present accompanied by Md.Mubarak Ali. The public authority is represented Md. Jeherul Islam E.O (P) and Sri Gauranga Ch. Dutta, Secretary, Napam G.P. The second appeal petitioner dated 27-6-2013 is taken up for hearing in presence of both the parties.

The BDO Incharge, Balipara Development Block has made a written submission stating that the RTI petition dated 20-11-2012 was transferred to the Secretary, Napam G.P for furnishing the required information to the petitioner. However, being aggrieved by non-response from the concerned public authority, the petitioner filed an appeal petition before the Deputy Commissioner, Sonitpur on 13-4-2013. After the first appeal petition the petitioner was furnished partial information by the Secretary, Napam G.P on 21st June, 2013, with which he was not satisfied.

The present G.P Secretary of Napam G.P Sri G.C. Dutta submitted that he has in the meanwhile compiled the required information and is in a position to furnish the same to the petitioner.

The Commission, therefore, directs the Secretary, Napam G.P to allow the petitioner to inspect the original records/ documents pertaining to the RTI petition and allow him to take notes thereof and photo copies of relevant documents free of cost up to 50 copies and thereafter on payment of Rs. 2/- for every additional copies. The process of record inspection, as above, shall be completed within 15 days from the date of receipt of this order.

With the above order and with a warning to the Secretary, Napam G.P not to repeat such delay in giving information on the RTI Act, in future, the second appeal petition dated 27-6-2013 is disposed of.
