O R D E R

The appellant Md. Abdul Razzak is present. The public authority is represented by Sri Biswajit Sarma, S.I of Schools, Dalgaon and Md. Mozammil Haque, Member Secretary, Ojhagaon Paschim Chuba L. P. School .

The second appeal petition dated 13-9-2013 is taken up for hearing in presence of both the parties.

The written submission made by the Block Elementary Education Officer, Dalgaon and Mission Coordinator and the Member Secretary of Ojhagaon Paschim Chuba L.P.School along with Annexures are entered into the case records.

The gist of the appeal case is that the petitioner Md. Abdul Razzak submitted an RTI petition dated 6-5-2013 to the Block Elementary Education Officer, Dalgaon , who transferred it to the Member-Secretary of the Ojhagaon Paschim Chuba L.P. School on 27-5-2013. The school Member-Secretary wrote to the petitioner on 13-5-2013 to deposit Rs. 1000/- for furnishing the information. The petitioner filed his first appeal petition before the District Mission Coordinator, Sarba Siksha Abhijan on 23-7-2013 stating the in spite of his repeated requests the Head Master of the school did not accept Rs. 1000/- towards the cost of furnishing the information. Getting no response from the first Appellate Authority the appellant filed his second appeal on 13-9-2013 before this Commission. On a query from this Commission, the appellant stated that he is still interested in getting the information by paying the cost of Rs. 1000/- and the Member Secretary of the L.P. School also stated that he has compiled the information for furnishing the same on receipt of the cost of Rs.1000/-.

The Commission, therefore, directs the Member Secretary of the Ojhagaon Paschim Chuba L. P. School to allow the petitioner to inspect the relevant records and documents and take notes and photo copies thereof by paying Rs. 2/- per page of photo copy of the documents that he may require within 15 days from the date of receipt of this order.

With this order the second appeal petition dated 13-9-2013 is disposed of.
