O R D E R

The appellant Md. Mustaq Ahmed of Kharupetia is present along with one Md. Saiful Islam. The public authority is represented by Smti Banashree Nath, PIO & Additional Deputy Commissioner, Darrang in the office of Deputy Commissioner, Darrang. The second appeal petition is taken up for hearing in presence of both the parties.

The Deputy Commissioner, Darrang has sent a written statement with 8 (eight) enclosures, which are entered into the case records.

The gist of the Annexure is that the required information was furnished to the petitioner first by the Additional Deputy Commissioner, Darrang on 24-8-2011 and 8-9-2011 and on 5-3-2012 by the Circle Officer, Dalgaoon Revenue Circle. The Deputy Commissioner also enclosed a copy of his order, as the first appellate authority dated 6-9-2011, directing the Circle Officer, Dalgaoon Revenue Circle to provide the relevant information to the petitioner. However, the appellant insisted that he is yet to receive the following :-

- (i) Full information regarding the plot of land where the hostel for the physically handicapped persons were constructed.
- (ii) Budget, estimates and drawing of the hostel building
- (iii) Copy of the work completion report.

The Addl. Deputy Commissioner and PIO deposed that the construction was taken up with un-tied fund of the office of Deputy Commissioner's Development branch for the year 2007-08 and the construction was done by a Construction Committee, constituted and headed by the Deputy Commissioner, Darrang. The fund sanctioned for the purpose was Rs. 18,40,000/-.

The position as of today is that although the Deputy Commissioner have submitted that information was furnished, the appellant insists that he is yet to receive the three information. To avoid any further communication gap, the Commission directs the PIO in the office of the Deputy Commissioner, Darrang to allow the appellant to inspect the relevant records/ documents, after giving 2 (two) days' notice, on any working day within 15 days from the date of receipt of this order and allow him to take notes as also photo copies of documents that he may require, free of cost up to 50 copies and on payment of Rs. 2/- for every addition copy thereafter.

With the above order the second appeal petition dated 17-8-2013 is disposed of.
