**ORDER**

The complainant and the public authority both are absent. However, the public authority, namely the Circle Officer, Sonapur Revenue Circle has made a written submission dated 8-10-2015, wherein it has been stated that as per office records, the RTI application dated 12-7-2013 from Sri Karabi Goswami was not received in the office of Sonapur Revenue . However, RTI application dated 14-9-13 , 16-8-2013, 21-9-2013 and 23-9-2013 from Sri Karabi Goswami were received and necessary information were furnished vide letters dated 16-9-2013, 18-9-2013, 8-10-2013 and 10-10-2013 all of which were received and acknowledged by Sri Karabi Goswami. The Circle Officer stated that he had also furnished necessary replies on 18-9-2013 and 19-9-2013 to the first appeal petition dated 6-9-2013 and complaint petition dated 6-9-2013 addressed to the Assam State Information Commission. Thereafter, vide further correspondence was received from Sri Karabi Goswami, the complainant.

The Commission notes that there were two more complaint cases on the same subject involving the same plot of land, filed by Sri Jinti Sarma, addressed to Secretary, Topatoli G.P, Dist- Kamrup (Metro)

The complaint case No. KP(M).579/2013 is against the Secretary of the Topatoli G.P, District- Kamrup (M) and the second complaint case No.KP(M).660/2013 is against the CEO of Kamrup (Metro) Zila Parishad.

Since the subject matter of all the three complaint cases are same, they will be heard on the next date of hearing.
