The SPIO/Secretary, Dakshin Ghilazari GPSS as well as Complainant were absent.

No written reply received from SPIO in response to Commission's hearing notice No.SIC/BPT.35/2015/5 dtd 1.10.15. Consequently Commission could not have the current position of the matter under complaint under the RTI Act, 2005.

Perused the case records which show that the application for information was made by Applicant to SPIO/Deputy Director, FCS&CA, Barpeta. SPIO on his part forwarded the Application to SPIO/Secretary, Dakshin Ghilazari GPSS through his letter No. BSM.42/2010/Pt-II/128 dtd 23.8.2012 asking for the requisite information by 14.9.2012. The Secretary of the said GPSS then wrote to 5 (five) Fair Price Shop proprietors to furnish the information by the said date, i.e. 14.9.12.

From the above, it appears that no follow up action was taken by SPIO/Deputy Director, FCS&CA, Barpeta and the SPIO/Secretary, Dakshin Ghilazari GPSS after they issued the said letters on 23.8.12 and 10.9.12 respectively.

T The Commission hereby directs that SPIO, FCS&CA and SPIO, Dakshin Ghilazari GPSS will collect the requisite information and make it available to Complainant/Applicant free of cost within 21 days of receipt of this order.

With this the complaint case No. SIC/BPT.35/2013 is disposed of.
