**O R D E R**

The Public Authority is represented by (1) Sri Tapan Kr. Das, SPIO in the office of the APSC, and (2) Sri Bishnu Momin, Jr. Administrative Asstt., APSC. The Appellant Dr. Dhruva Jyoti Nath is present. The second appeal petition is taken up for hearing in presence of both the parties.

This is the second hearing of this appeal. It had been heard by the Commission earlier on 5.12.2013 and order issued directing the SPIO to take necessary steps to furnish the copies of the relevant records within 10 days from the date of receipt of the order.

Perused the letter No. 22PSC/RTI-01/107/2012-2013 dtd 24.9.15 received in the Registry of the Commission from the SPIO, APSC submitting, inter alia, that the third party information is now ready to be provided to the Appellant, namely details of the educational qualifications and the experience of the OBC candidates selected by the Assam Public service Commission for the posts of IS/DEEO/Deputy Director in the Education Department.

The SPIO, APSC confirmed personally the position stated in the said letter of 24.9.15.

The Appellant deposed that he would be satisfied if the said details of the educational qualifications and experience of the concerned candidates are now made available to him officially by the APSC.

In view of the above, the Commission has decided to dispose of the case with the direction to the APSC that information as stated above would be made available to the Appellant officially within 10 days of the receipt of this order.
