Neither the Public Authority nor the Appellant were present.

Having not received the information sought for by the Applicant he filed the First Appeal dtd. 06.11.12 to the DC, Barpeta and the Second Appeal to Commission

No written submission received from the SPIO in the office of the AGM(RE Monitoring), APDCL, Barpeta, Bhakatpur Electrical Sub-Division, Dist. Barpeta.

In the absence of Appellant in the hearing, the Commission could not determine as to whether information sought for by the Appellant has been provided to him.

In view of the facts and circumstances stated above, this Commission hereby orders that the SPIO in the office of the AGM (RE Monitoring), APDCL, Barpeta will ascertain as to whether the information sought by the Applicant has been furnished to him, and if not he will furnish the same within 15 days of receipt of this order.

The Commission also orders that Managing Director, APDCL will have the appropriate First Appellate Authority consider and dispose of the First Appeal filed by the appellant/Applicant Md. Zakir Hussain within 30 days of receipt of this order..

According to the records available with the Commission, the Applicant filed First Appeal to Deputy Commissioner, Barpeta. However, as APDCL ought to have its own First Appellate Authority appropriate in respect of AGM (RE Monitoring), APDCL, Barpeta. A copy of the application dtd 21.5.12 submitted by the Applicant and of First Appeal dtd 25.8.12 submitted to Deputy Commission, Barpeta be sent to Managing Director, APDCL.
