- 12.11.12. Information said to be provided by the CDPO, ICDS Project, Borkhola to the Applicant
- 11.12.12 .Not being satisfied with the information provided as sought for, the Applicant submitted Second Appeal before the Commission

The SPIO of CDPO, ICDS Project, Borkhola, Cachar submitted personally and through the written submission No. CDPO(BKL)RTI/25/Pt-I/2015-16/50 dtd 19.10.2015 addressed to the Commission by the CDPO, Borkhola ICDS Project that the information sought for by the Applicant had been furnished to him through letter No. CDPO(BKL)RTI/25/Pt-I/2009-10/96 dtd 12.11.2012. No additional explanation could be given with reference to the Second Appeal by the Applicant wherein he had stated that the information received by him were not supported by any documents. Further, the SPIO submitted that the Applicant had not contacted him after receiving the said information and therefore, he did not know that the Applicant was not satisfied with the information supplied.

In view of the above, it is hereby ordered that the Appellant/Applicant Md. Asif Uddin Barbhuiya will write to the SPIO in the office of the CDPO, Borkhola ICDS Project specifying any additional information/documents required by him if any in connection with the Application he had made on 16.8.12 within a period of 15 days of receipt of this order. The SPIO shall respond promptly, in any case not later than 30 days after receipt of the said clarificatory application from the applicant Md. Barbhuiya, if any, free of cost.

The Second Appeal petition is disposed of.
