On perusal of records, it appears that the Complainant/Applicant has not filed First Appeal Petition before the First Appellate Authority.

The representative of SPIO submitted a written submission. Perused the same. It appears that the appellant had received some information from the SPIO. However, he was not satisfied with the extent of information he had received. He had conveyed his reservations on this to SDO (Civil), Bajali through his letter dtd 7.6.12.

Considering the facts and circumstances of the case, it is hereby orders that SPIO, office of the SDO (Civil), Bajali will provide the Applicant with the complete information he had sought and inform him if any part of the information is not available to be provided within a period of 15 days from the date of receipt of this order.

Attention of the Public Authority is drawn to the provisions in the said Act regarding penalty for delay in providing information to Applicants under the Right to Information Act, 2005 which provides for penalty and recommendation to the administrative department to initiate disciplinary proceedings against the SPIOs who are guilty of delay and negligence.
