ORDER 05.11.2015

Public Authority was represented by (1) Shri Bijoy Ch. Kalita, Deputy Secretary to the Govt. of Assam, PW(R) Deptt & SPIO, and (2) Shri Hare Krishna Sharma, APIO & Asstt. Engineer, Udalguri Rural Road Division, Udalguri.

Appellant was absent.

Perused the records in the Second Appeal Case.

The following is the sequence of events:.

16.12.13	RTI Application submitted to Director, Finance
	(Eco. Affairs)
16.1.14	First Appeal preferred to Director, Finance (Eco. Affairs)
20.3.14	Second Appeal filed to Commission
15.10.15	Hearing Notice.

Perused the written submission received from the SPIO/Deputy Secretary, Govt. of Assam, PWD (Roads) and the written statement received from the Executive Engineer, PWD (Rural Roads) Division, Udalguri. It transpires from both the written statements that the information sought for was ready to be furnished to the Appellant/Applicant. However, the latter could not be contacted. A copy of the letter No. G/RTI/2005/248/821 dtd 15.5.14 has been enclosed with the W.S. which indicates that the letter had been issued to the Applicant requesting him to collect the information from the office as the office was located in the same locality. It could not be confirmed whether the said letter had been actually delivered to the Applicant and that the latter (the Applicant) did not attend the office in response to that letter.

The case records also indicate that the copy of the hearing notice which had been posted to the Appellant returned undelivered.

In view of the above facts, it appears that the Applicant has either changed his address or is unanimous.

In view of the above facts and circumstances, the Second Appeal petition is disposed of.
