O R D E R

Seen the appeal petition dated 21-12-2013 and the RTI petition dated 11-11-2013 of Sri Pavitra Phukan. The RTI petition dated 11-11-2013 was submitted to the SDO (Civil), Dhansiri Sub Division, Sarupathar, District- Golaghat.

It appears from the case records that the RTI petition was transferred by the SDO (Civil) to the Principal of Borpathar Higher Secondary School, P.O- Borpathar, Dist- Golaghat, PIN-785 602, The Principal of the school replied to the RTI petition stating that Borpathar Sangeet Mahavidyalaya is a purely non-Governmental Institution which runs in the premises of Borpathar Higher Secondary School every Saturday from 2 to 4 P.M (after school hours) and on Sundays (from 9.30 A.M to 12.30 P.M). It is mentioned in reply to the RTI petition that the Music College is running on the basis of verbal suggestion of the then Managing Committee and that the Inspector of Schools, Golaghat also granted the prayer for running the Borpathar Sangeet Mahavidyalaya in the premises of Borpathar H.S School.

With a view to furnishing precise and to the point reply to the RTI petition, this Commission passes the following directions :

1. The Principal of Borpathar H.S. School will furnish a copy of the written permission of the School Management Committee to run the Borpathar Sangeet Mahavidyalaya in the premises of Borpathar H.S. School. If no such written permission exists, the petitioner should be informed accordingly within 15 days from the date of receipt of this order.
2. The Principal of Borpathar H.S. School will inform the petitioner if any written permission has been given by the Inspector of Schools, Golaghat for the same purpose, and if so, whether it is on the basis of the recommendation of the School Management Committee. If no such written permission of the Inspector of Schools , Golaghat exist, then the Principal of Borpathar H.S. School will furnish a copy of the same to the petitioner within 15 days from the date of receipt of this order. If no such
