O R D E R

The petitioner Md. Abdul Jalil is absent without information. The public authority is represented by Md. Abdul Karim of Belsiri GPSS, District- Sonitpur.

The second appeal petition dated 18-2-2013 is taken up for hearing ex parte in absence of the petitioner.

The Secretary of the Belsiri GPSS made a written submission dated 12-11-2015, which is entered into the case records. In his written submission he stated that Ration Card No.- 402113 Sl. No. 17 is continued till today in the name of Md. Abdul Barik, son of Late Mamud Ali, vill-Kotoludul. Md. Abdul Barik is lifting PDS commodities against that card. It is seen from the case records that in his letter dated 8-9-2012 the Secretary, Belsiri GPSS informed the petitioner Md. Abdul Jalil that Family Identity Card No. 402113 was in the name of Smti Saraswati Karmakar, wife of Late Bhupen Karmakar. By his written submission dated 12-11-2015, the Secretary, Belsiri GPSS admitted that this information which was furnished by him earlier was wrong. The FIC No. of Smti Saraswati Karmakar is 412600. The Secretary, Belsiri GPSS also produced a copy of the FIC Card No. 412600 in the name of Md. Abdul Jalil which was surrendered by Md. Abdul Jalil on 14-11-2008 due to change of residence. Secretary, Belsiri GPSS issued the surrender certificate. It is therefore, confusing as to whether the petitioner's card No. mentioned in his RTI petition i.e. FIC No. 402113 Sl. No.-17 was in his name or not other is confusing. It appears that some manipulation of records might have taken place involving creation of "Ghost Ration Cards"
