O R D E R

The appellant Md. Johirul Islam is present. The public authority to be represented by the SPIO of Jaleswar Development Block is absent without information. The second appeal petition dated 8-10-2013 is therefore, taken up for hearing ex-parte.

From a perusal of case records, it is seen that the appellant, vide his RTI petition dated 21-6-2013 sought information on residency of Md. Arsad Ali and details of financial sanctions and other benefits given to Md. Arsad Ali against Job Card No. AO-04-007-017-008/18-C of Panikamratary village of Darangapur G.P of Jaleswar Dev. Block , Dist- Goalpara.

The appellant has furnished a copy of the relevant Job card list with names of beneficiaries before this Commission. The appellant Md. Johirul Islam whose name also figure in the same list and who also is a resident of Panikamratary village, suspects that there is no person by the name of Md. Arsad Ali in his village. Moreover, House No. 18 shown against Md. Arsad Ali is the house of the appellant Johirul Islam and there is no person named Md. Arsad Ali in his household. This is a serious allegation

In view of the above the Commission directs the Project Director, DRDA, Goalpara to cause an enquiry into the allegation and furnish the required information to the appellant within 30 days with intimation to this Commission. If the allegation is found to be true, the P.D, DRDA is directed under Section 20 of the RTI Act, 2005 to draw up departmental proceedings and take other necessary measures on the person/s found guilty.

The Commission also directs the P.D, DRDA to issue a warning to the BDO, Jaleswar Development Block for his unauthorized absence in the hearing today.

With the above order, the second appeal petition is disposed of. Send a copy of this order to the Commissioner & Secretary, Panchayat & Rural Development for his information and necessary action.
