**O R D E R**

The petitioner Sri Indra Rongpher is present accompanied by one Sri Sarlongki Bey. The public authority to be represented by the SPIO in the office of Inspector of Schools, Karbi Anglong district is absent.

The Joint Secretary, Education, Karbi Anglong has made a written submission dated 17-10-2015 as the First Appellate Authority, stating that the original RTI petition dated 3-12-2012 has been forwarded to Inspector of Schools, Karbi Anglong district for furnishing the information to the appellant.

The Inspector of Schools has made a separate written submission dated 17-10-2015 stating that the required information has already been furnished to the applicant.

The applicant Sri Indra Rongpher has made another written submission dated 23-10-2015 stating that he has been given only partial information by the office of Inspector of Schools.

When asked by this Commission about which part of the information he was not given, he submitted that the names of the Schemes of the works against each letter numbering 13 mentioned in the Annexure of his original RTI petition dated 3-12-2012 has not yet been furnished to him. Since it is mandatory that specific mention of name of work/ Scheme/ Project or any other purpose must be mentioned in the sanctioning order/ letter involving any public expenditure, the Commission directs the SPIO in the office of Inspector of Schools to furnish the names of work/ Scheme/ Project or purpose for which expenditure of public fund was sanctioned or for which Inspector of Schools, submitted proposals to the Karbi Anglong Autonomous District within 15 days from the date of receipt of this order.

With the above order the second appeal petition is disposed of.
