**O R D E R**

The petitioner/ second appellants and the public authority to be represented by the SPIO of North Lakhimpur Municipal Board, both are absent.

However, the Chairman, North Lakhimpur Municipal Board has sent a written submission dated 26-10-2015 stating that in response to the RTI application dated 27-2-2013 of the applicant Sri Dhiraj Lahkar, the required information was sent to the applicant on 16-8-2013 vide letter No. NLMB/RTI/2013-2014//46 dated 11-12-2013 through office peon and peon book. It is stated in the written submission that the applicant refused to receive the information which is recorded in the office peon book against entry dated 16-8-2013. Thereafter, the Chairman reported the matter to the Addl. Deputy Commissioner, North Lakhimpur vide his letter dated 11-12-2013 with which photo copies of documents which were sent to the RTI applicant who had refused to accept the same, were enclosed. Thereafter, the matter does not seem to have progressed any further. It is also not clear from the case records whether the Addl. Deputy Commissioner, North Lakhimpur furnished the information to the applicant.

In view of the above, this Commission disposes of the second appeal petition dated 14-11-2013 with a direction to the SPIO of North Lakhimpur Municipal Board to allow the applicant, if he wants to inspect the relevant documents or take photo copies thereof, within office hours on any working day, free of cost, within 15 days from the date of receipt of this order.
