Sri. Sofiul Alam, APO (A) and SPIO, DRDA, Nagaon present.

The Petitioner Sri Kushal Bora is present.

A perusal of the case records indicate the following significant dates:

22.05.2013 Filing of the RTI application before PD, DRDA, Nagaon.

24.06.2013 First Appeal filed by the Applicant.

06.09.2013 Complaint filed by the Applicant before the Commission.

In a written statement submitted before the Commission, the SPIO stated that the RTI Application had been transferred to BDO, Lawkhowa Development Block and that the latter had written a letter to the Applicant requesting him to collect the information from his office. A copy of the letter written by BDO, Lawkhowa Development Block to the Applicant dated 05.10.2013 has been enclosed with written statement.

The SPIO reiterated the above position in his personal submission.

Complainant submitted that he has neither received the information sought for nor the aforementioned letter from the BDO, Lawkhowa Development Block.

Considering the facts and circumstances stated above, the Commission hereby orders

Further, as the RTI Application and the First Appeal had been filed before him, PD, DRDA, Nagaon may ascertain from the BDO, Lawkhowa Development Block within 30 days from the date of receipt of this order to ensure that the RTI Applicant has been provided with the information he had sought for and that the orders of this Commission in this regard have been complied with.

With this, the complaint case is disposed of.
