## ORDER

The petitioner/ appellant Sri Dulal Bora is present. There was none to represent the public authority. However, Secretary to the Govt. of Assam, Home & Political Department has sent a written submission dated 28<sup>th</sup> October, 2014 stating that he is not the first appellate authority in respect of the SPIO in the office of Suptdt. of Police, Jorhat. He has stated that the DIG (Eastern Zone) is perhaps the first appellate authority in this case. The RTI petition relates to a law and order incident involving Life Insurance Corporation of India at Jorhat on 13<sup>th</sup> May, 2009.

On perusal of the second appeal petition dated 10-6-2013 and enclosed copies of the first appeal petition dated 2-5-2013 and the RTI petition dated 21-3-2013 it is seen that both the RTI petition and the first appeal petitions were addressed to the Principal Secretary, Home Department, Govt. of Assam. It is further seen that the Suptdt. of Police, Jorhat vide his letter No. V/CD-60/30/3021 dated 4<sup>th</sup> May, 2013 wrote to Sri Dulal Bora, the appellant in response to his RTI petition. Sri Dulal Bora stated before this Commission that he has received the communication only day before yesterday i.e., 1<sup>st</sup> November, 2015.

However, from perusal of the communication dated 4<sup>th</sup> May, 2015 from the S.P., Jorhat, it is seen that copy of the inquiry report of the then Additional Chief Secretary, Sri P.P.Varma has not been furnished and the applicant was asked to collect the same from that office. Since the inquiry report is expected to be available with the Political Department, Govt. of Assam, the Commission directs the PIO of the Political Department to either furnish a copy of the report to
