## ORDER

The second appellant Sri Jatin Saikia and the public authority to be represented by the Head Mistress of 239 No. Nalkata, L.P. School, Khelmati, North Lakhimpur, Dist-Lakhimpur, Assam both are absent without information.

Therefore, the second appeal petition dated 25-7-2013 is taken up for consideration ex-parte.

From perusal of the case records, it is seen that the petitioner filed a revised RTI application dated 30-4-2013 before the Head Mistress of 239 No. Nalkata L.P. School, Khelmati, North Lakhimpur, Dist- Lakhimpur, PIN-787001 seeking information of drawl of arrear pay bills for the period -1-4-1996 to 31-1-2002 in the name of Sri Lobo Gogoi, Teacher of the above-mentioned School. The 5 points on which he sought information were listed in the Annexure to the RTI application. After not receiving any information from the School Head Mistress, the petitioner filed his first appeal petition on 22-6-2013 again before the Head Mistress of the above-mentioned school. Getting no response to the first appeal petition also, the appellant filed a second appeal petition before this Commission on 25-7-2013. In his second appeal petition it has been mentioned that the appellant suspects, based on confidential information, that the Block Elementary Education Officer in collusion with some teachers of the said school drew the arrear salary in the name of teacher Sri Lobo Gogoi in a fraudulent manner. If true, this is a serious matter. As mentioned in the Preamble of the RTI Act, 2005, "One of the objects of the
