O R D E R

The second appellant Sri Ghanashyam Jalan is present. The public authority is represented by (1) Smti Manorama Morang, Circle Officer (A), Dispur and (2) Sri Mukul Kathar, SDO (Sadar) , Kamrup (Metro).

The second appeal petition dated 3-2-2014 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner, vide his RTI application dated 15-7-2013 filed before the Deputy Commissioner, Kamrup (Metro), sought certified copy of order in Misc Case No. 277/2010 dated 15-12-2010. On 16-7-2013 the PIO of the office of Deputy Commissioner, Kamrup (Metro) transferred the petition to Circle Officer, Dispur Revenue Circle. It is seen from the case records that the appeal petition was filed before the Deputy Commissioner, Kamrup (Metro) as the First Appellate Authority. The First Appellate Authority heard the same and passed orders on 19-10-2013 directing the Circle Officer, Dispur Revenue Circle to give certified copy of the order in Misc Case No. 277/10-11 dated 15-12-2010 within 15 days from the date of receipt of his order. After not getting any response from the Circle Officer in compliance with the FAA's order dated 19-10-2013, the petitioner filed his second appeal petition before this Commission on 3-12-2014. On 21-11-2015 the SPIO of Deputy Commissioner, Kamrup (Metro) made a written submission before this Commission stating the actions taken by the FAA and that the Circle Officer, Dispur, Revenue Circle informed the petitioner vide letter dated 25-10-2013 that the relevant case record could not be found in the Circle Office. A copy of this letter has been enclosed by the PIO of Deputy Commissioner, Kamrup (Metro).

The Circle Officer , Dispur Revenue Circle prayed for 30 days time to search for the relevant case record and furnish the same to the petitioner/ appellant. This Commission grants her prayer and gives 30 days time to search out the relevant record and furnish a true copy of the same to the petitioner by Registered A/D post within 30 days from the date of receipt of this order.

With the above order the second appeal petition is disposed of.
