O R D E R

The petitioner Md. Zakir Hussain is absent without any information. The public authority is represented by Sri Manash Das, Deputy Director, WPT&BC accompanied by one Sri Mohan Hazarika, Sr. Asstt. of the office of Director, WPT&BC Department.

The petition dated 31-12-2013 complaining upon non-compliance of this Commission's order dated 10-12-2013 is taken up for consideration ex-parte in the absence of the petitioner.

From perusal of the case records it is seen that the then State Information Commissioner Sri M.C.Malakar vide his order dated 10-12-2013 had directed the Director of WPT&BC to furnish the required information to the petitioner. The information sought for relates to Maria Development Block. On careful consideration it is seen that out of the four information the first two , namely:-

- (i) **Sanction letters of Grants-in-aid for Maria Development Block for the years 2011-12 and 2011-12 and**
- (ii) **Release letters of the same for both the years should be available with the Directorate of WPT&BC.**

The other 2 information, namely :-

- (iii) **Construction work orders for both the years and beneficiary list with APR for both the years should be available with the Maria Development Council, Hatigaon , Guwahati.**

The Commission, therefore, directs the Director, WPT&BC and the Chairman, Maria Development Council to allow the petitioner to inspect the relevant documents, records and files pertaining to his RTI petition during office hours on any working day within 20 days from the date of receipt of this order and allow him to take notes as well as photo copies of the documents sought for by him free of cost up to 50 copies within 20 days from the date of receipt of this order and allow him to take notes as well as photo copies of the documents sought for by him free of cost up to 50 copies and thereafter on payment of Rs. 2/- for every additional copy.

With the above order the petition dated 31-12-2013 is disposed
