ORDER

The petitioner Smti Oshima Choudhury is absent without information. The public authority is represented by (1) Shri Dhirendra Nath Kalita, FAO, Directorate of Pension, (2) Sri Sunil Kr. Das, FAO, Office of the Director of Pension (3) Sri Devojit Paw, LDA and (4) Sri Satish Ch. Bhattacherjee, Superintendent.

The complaint petition dated 19-10-2013 is taken up for hearing ex parte in the absence of the petitioner/ complainant.

From perusal of the RTI petition dated 9-9-2013, it is seen that the information sought for is already covered under a separate complaint petition dated 5-10-2013, leading to pension matters of Smti Sayeda Arifa Begum (wife of Late Saifur Rahman), Asstt. Teacher in Baghorbari L.P.School, Guwahati. That complaint petition was also heard today in complaint case No. **KP(M)667/2013**, where the D.I of Schools, Kamrup (Metro) is the responding public authority. Therefore, the Commission clubs both the cases together for further necessary action.

The respondents present in the instant case deposed that if the PPO No. and Case Mark No. of the Family pension is being drawn by Smti Sayeda Arifa Begum are provided by the petitioner/ complainant then the Directorate of Pension will be able to furnish the required information. In case No. **KP(M)667/2013** heard today, the D.I of Schools furnished the PPO No. for the Family Pension drawn in Sivsagar as **E/FP/56496**.

This Commission therefore, directs the petitioner/ complainant to provide the PPO No. and Case Mark No. of the Family Pension/pensions allegedly being drawn by Smti Sayeda Arifa Begum to the Director of Pension within 30 days from the date of receipt of this order.

The Directorate of Pension has also in the meanwhile written to the petitoiner vide letter dated 26-10-2015 asking for the detailed particulars. This Commission directs the Director of Pension to provide the particulars about the bank account from which Smti Sayeda Arifa Begum is drawing her pension on the basis of the PPO No as mentioned above and communicate the information to the complainant Smti Oshima Choudhury within 45 days from the date of receipt of this order.
