O R D E R

The petitioner Sri Kanlara Hazarika is absent without information. Sri Ajit Kumar, SPIO-cum- Deputy Director , Food and Civil Supplies and Consumer Affairs Department, Lakhimpur is present.. The second appeal petition dated 17-7-2013 is taken up for hearing ex parte in the absence of the petitioner/ appellant.

The PIO-cum- Deputy Director has made a written statement dated 13-11-2015 stating that on instruction from the First Appellate Authority, i.e., Additional Deputy Commissioner, Lakhimpur, North Lakhimpur, the Deputy Director, FCS&CA, North Lakhimpur furnished the information, as available at that time to the petitioner vide letter dated 29-4-2013 He further stated that vide letter dated 15-6-2013 the petitioner was again informed to deposit Rs. 28/- as photo copy charges for providing copy of the Inquiry Report. But the petitioner did not deposit the required cost. When asked by this Commission, the SPIO stated that the Inquiry has since been completed and the report is ready for furnishing to the petitioner.

Since the request for depositing the cost of photo copy was made by the SPIO after the expiry of 30 days, this Commission directs the PIO and Deputy Director, FCS&CA , Lakhimpur, North Lakhimpur to furnish a copy of the Inquiry report in response to the RTI petition dated 8-4-2013 to the petitioner by Registered A/D Post within 15 days from the date of receipt of this order.

With this order the second appeal petition dated 17-7-2013 is disposed of.
