**O R D E R**  
08.12.2015

The petitioner Sri Biswajit Nath and the public authority to be represented by Circle Officer, Sonapur Revenue Circle, Sonapur both are absent without information.

The Second Appeal Petition dated 25.11.2013 is taken up for consideration ex parte in the absence of both the petitioner and the respondent.

The Circle Officer, Sonapur Revenue Circle, Sonapur has made a written submission on dated 07.12.2015 which is entered into the case records.

In the written submission, the Circle Officer, has stated with supporting documents that following order dated 19.10.2013 of the First Appellate Authority, reply to the RTI petition has been furnished vide letter dated 10.12.2013. The reply to the RTI petition dated 07.05.2013 was furnished to the petitioner, receipt of which was acknowledged by the petitioner on 11.12.2013.

In his reply dated 10.12.2013, the Circle Officer, Sonapur Revenue Circle mentioned that the information to the petitioner might not be correct as the petitioner did not mention the names of the villages and the Mouzas.

The Circle Officer, Sonapur Revenue Circle, has enclosed copies of the Jamabandi and report dated 05.12.2013 of the Lot Mandal regarding allotment of land by Government to Sri. Sanjay Goswami and Sri. Tridib Sarmah.

It is presumed that the copies of the same were also furnished to the petitioner.

This Commission notes that the Second Appeal Petition dated 25.11.2013, which is prior to 10.12.2013, the date on which the Circle Officer, Sonapur Revenue Circle, Sonapur furnished the information.

In view of the absence of the petitioner in today's hearing and since there is no further communication from him, this Commission is inclined to conclude that the petitioner is satisfied with the information received by him. In case he has not received the information or if he is not satisfied, the Commission directs the petitioner to approach the Circle Officer, Sonapur Revenue Circle, Sonapur personally within 30 days from the date of receipt of this order with the names of concern villages and Mouzas.

The Circle Officer, Sonapur Revenue Circle, Sonapur is directed to allow the petitioner to inspect the relevant records and documents in relation to his RTI petition dated 07.05.2013 on any working day during office hours within 30 days from the date of receipt of this order.

The petitioner will be allowed to take notes and photo copies of documents that he may require, free of cost up to 25 copies and thereafter, on payment of Rs. 2/- for every additional copy.

With the above order, the Second Appeal Petition is disposed of.
