6.8.12	Second Appeal filed before the Commission.
8.10.15	Hearing Notice.

Perused the above mentioned WS. It has been submitted through the WS that the Secretary of the concerned GP, Jarailtola GP, Dist. Cachar had written a letter to the RTI Applicant dated 23.10.15 to visit the office of the Gaon Panchayat and receive the information sought for.

Considering the submission in the above mentioned WS, it is hereby ordered that Secretary, Jarailtola GP will send free of cost, the information sought for by the Applicant to his address by post within 10 days of receipt of this order.

It is seen that PD, DRDA, Cachar has not disposed of the First Appeal submitted by the Applicant through his Appeal dtd 8.6.12. PD, DRDA did not make any WS to the Commission despite requested to do so by the Commission through the Hearing Notice. No. SIC/CCR/170/2012/8 dtd. 8.10.15. It is therefore, ordered that PD, DRDA, Cachar will consider and dispose of the First Appeal submitted by the Appellant dated 8.6.12 with a speaking order within 21 days of receipt of this order.
