21.11.13	Second Appeal filed before the Commission.
29.10.15	Hearing Notice

Perused the WS submitted by the SPIO and Sr. Sub-Registrar, Tinsukia. It has been submitted that the information as sought for by the Appellant through his application dtd.12.8.13 had been furnished on 27.9.13 through letter No. TSR-4/2008/220. The Sr. Sub-Registrar submitted that his predecessor had furnished a reply to the Applicant to the effect that there was no mention on sale permission from the Deputy Commissioner on the Sale Deed.

The written submission and personal submission of the current SPIO re-affirm what the Appellant/Applicant had stated that there was no sale permission from the Deputy Commissioner. Further, the information sought for by the Appellant as to how the sale deed could be registered, has remained unanswered.

In view of the above, it is hereby ordered that the SPIO will explain to the Appellant in writing as to how the registration of the concerned landed property could be registered without permission for sale from the Deputy Commission within a period of 15 days from the date of receipt of this order.

With the above orders the Second appeal is disposed of.
