**O R D E R**  
15.12.2015

The Petitioner/Second Appellant Shri Harinarayan Pathak is present. The Public Authority is represented by Shri Saurabh Sharma. DGM & SPIO in the office of the Directorate of Geology and Mining, Assam, The Second Appeal petition dtd 11.11.13 is taken up for consideration in presence of both the parties.

From perusal of the case records it is seen that the Petitioner filed an RTI petition dtd. 4.7.13 before the SPIO, Directorate of Geology & Mining followed by a First Appeal petition dtd. 10.8.13. On 2.9.13 the FAA informed the Petitioner that information sought for by him was being compiled and will be furnished to him shortly. Vide letter dtd 8.10.13 the SPIO of the Directorate of Geology and Mining furnished the information to the petitioner point-wise.

From perusal of the Second Appeal petition dtd 11.11.13 it is seen that the Second Appeal petition is based entirely on the perception of the Appellant that the information furnished vide the SPIO's letter dtd 8.10.13 was incomplete. The Appellant could not substantiate his perception. The Appellant prayed that today inadvertently he did not come prepared with his records.

The Commission therefore, directs the SPIO of Geology & Mining, as prayed by the Appellant, to allow him to inspect the relevant records and documents on any working day within 15 days of pronouncement of this order which was pronounced in presence of both the parties and clarify his doubts.

With the above order, the Second Appeal Petition is disposed of.
