ORDER 15.12.2015

The Petitioner/Complainant as well as the Public Authority – both are absent without any information. The complaint petition dtd 29.7.13 is taken up for consideration ex-parte in the absence of both the Petitioner as well as the respondent.

From perusal of the case records it is seen that the Petitioner filed an RTI petition dtd 20.4.13 before the Chairman Bihpuria Town Committee. The Chairman of the Bihpuria Town Committee replied to the RTI petition point-wise vide his letter dtd 26th June, 2013. Not satisfied with the reply, the Petitioner filed a First Appeal petition before the Deputy Commissioner, Lakhimpur. Thereafter he filed another petition dtd 29.7.13 before this Commission for necessary action of this Commission.

From perusal of the First and Second Appeal petitions it is seen that they are in nature of allegations regarding utilization of fund for various schemes against the Bihpuria Town Committee. It is also seen from the case records available before the Commission that the First Appeal petition dtd 2.7.13 remained unresolved by the Deputy Commission, Lakhimpur as the First Appellate Authority. This Commission therefore, remands the First Appeal petition along with the Second Appeal Petition to the Deputy Commission Lakhimpur for disposal with a speaking order after hearing both the parties within 30 days from the date of receipt of this order.

With the above order, the complaint/Appeal petition dtd 2.7.13 is disposed of.
