The petitioner, Md Abul Kalam Azad as well as the Public Authority represented by the PIO in the office of the Executive Officer, Nagaon Wholesale Consumers' Co-operative Society – both are absent without information. The Second Appeal petition dtd 22.7.13 is therefore, taken up for consideration ex-parte in the absence of both the parties.

From perusal of the case records it is seen that the Petitioner filed an RTI petition dtd 9.4.13 before the PIO in the office of the Executive Officer, Nagaon Wholesale Cons. Co-operative Society seeking information required by him. The Applicant filed a First Appeal petition dtd 17.5.13 addressed to the Dy. Registrar, Co-operative Societies, Nagaon and the Second Appeal petition dtd 22.7.13 before this Commission apparently for non-receipt of the required information.

From perusal of the RTI application it is seen that the information sought for are admissible under the RTI Act, 2005. The Commission therefore, directs the Executive Officer, Nagaon Wholesale Cons. Cooperative Society Ltd to allow the Petitioner, if he wants to do so, to inspect relevant documents/ records pertaining to his RTI petition dtd 9.4.13 on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of documents as may be required by him free of cost upto 25 copies and Rs. 2.00 per additional copy thereafter.

With the above, the Second Appeal petition dtd 22.7.13 is disposed of
