The Petitioner Shri Dipu Talukdar is absent. However, he sent a written representation stating that today he will be out of station due to medical treatment of his family members. The Public Authority is represented by (1) Md. Abdur Razzaque, SPIO & Dy. DEE, Assam, (2) Shri Khagen Deka, Statistical Assistant, (3) Shri Dhiraj Ch. Das, RA, office of the DEE, Assam, and (4) Shri Nitul Barman, Sr. Administrative Asstt., Education Department, Dispur.

The SPIO submitted a copy of the letter dtd 8.12.15 addressed to the petitioner/Appellant Shri Dipu Talukdar from the Dy. Director, Elementary Education, Kahilipara, Guwahati, Assam furnishing the required information to the Petitioner with a copy to the Secretary and Registrar of this Commission. The Deputy Director, Elementary Education has given break up of 280 sanctioned posts for the LP Schools and mentioned 135 as number of sanctioned posts for ME/UP Schools. Regarding 8 sanctioned posts for LP Schools and 5 sanctioned posts for ME Schools for Tihu Mouza which falls under Nalbari District but in the LAC of Patacharkuchi which was allotted to the DEEO, Barpeta. The Director, EE Assam wrote to the DEEO of Barpeta and Nalbari District vide letter dtd 21.3.2001 for transfer of those posts from DEEO, Barpeta to DEEO, Nalbari. In the Dy. Director's letter dtd 8.12.15 it has been mentioned that the Directorate of Elementary Education is not aware of action taken by the DEEO, Barpeta for transfer of those posts to Nalbari and whether DEEO, Nalbari has received those posts. The

Commission therefore, directs the Director, Elementary Education, Govt. of Assam to ascertain the latest position in this regard from the DEEO, Barpeta and DEEO, Nalbari and inform the same to the Petitioner within 30 days from the date of receipt of this order.

In view of the above facts that the information has since been furnished, the Second Appeal petition dtd 11.8.14 is disposed of.
