ORDER 11.12.2015

The Petitioner/Appellant Smt. Reena Kalita is absent without information. The Public Authority to be represented by the SPIO of the office of the Chairman, Tezpur Municipal Board is also absent. But the Chairman, Tezpur, Municipal Board has sent a written submission dtd 8.12.15 enclosing supporting documents.

The gist of the written submission is that as per Tezpur Municipal Board's records, the Holding No. 9/5 of Word No. 8 of Tezpur Municipality was never in the name of Lt. Nalini Ranjan Kalita. It was in the name of Mrs Juri Kalita, wife of Shri Rohini Ranjan Kalita, which was transferred to one Shri Babul Sarkar on 10.01.2008 by following due procedure and after receipt of Rs. 13,500 as transfer fee. The Chairman, Tezpur Municipal Board has furnished supporting documents. A copy of his letter dtd 8.12.15 addressed to this Commission and mentioning the above facts has also been given to Smt. Reena kalita.

In view of the above, this Commission directs that if Smt. Reena Kalita has in her possession any document in support of her contention that Holding No. 9/5 was in the name of her deceased husband Lt. Nalini Ranjan Kalita, then the Chairman of Tezpur Municipal Board will allow her to inspect relevant records/files and documents of Tezpur Municipal Board during office hours on any working day within 15 days from the date of receipt of this order and allow her to take notes or photocopies of any document required by her in relation to her RTI petition dtd 6.7.12 free of cost up to 10 pages and thereafter on payment of Rs. 2.00 for every additional copy.

With the above order the Second Appeal dtd 16.7.13 is disposed of.
