Perused the written statement dtd 4.11.15 submitted by the Director, Elementary Education, Assam and First Appellate Authority. In his WS the Director has enumerated chronologically the significant dates relating to the handling of this RTI Application. It has been submitted that the copy of the inquiry report of Shri A.B.N. Singh, ACS, the then SDO (Sadar), Karimganj, select list of the candidates have been 'furnished' to the petitioner in the presence of the Commission in its hearing on 12.2.15 and that hese have subsequently been forwarded to the petitioner through a letter dated 3.11.2015.

Perused the Commission's order dtd 12.2.15. In its order the Commission had taken note of the submission of the said documents and had directed that if the petitioner desired an authenticated copy, he could obtain it from the office of the Deputy commission, Karimganj, where the report originated.

A perusal of the records relating to Second Appeal Petition No. KP(M) 453/2013 in respect of which an order was issued by the Commission on 12.2.15and those of KMJ.2/2014 indicate that the two Second Appeal cases filed by Shri Shyamal Dutta are one and same thing, the apparent reason for creation of a second case namely KMJ.2/2014 being repeat Second Appeal submitted by the Appellant dtd 20.11.13, after the First Appeal dtd. 3.7.13.

The Appellant submitted verbally that he was unable to procure an authenticated copy from the office of the Deputy Commissioner, Karimganj.

After a careful consideration, the Commission hereby reiterates its order of 12.2.15, namely he should approach the office of the Deputy Commissioner, Karimganj for an authenticated copy of the documents, if he so wishes..

With this the Appeal is disposed of.
