The representative of the Appellant submitted that the latter has not received any information that he had sought for from the Secretary, Ratabari GP, Dist. Karimganj. In his written submission dtd 20.11.15, Secretary, Ratabari GP stated that he had joined the GP on 21.1.15 and he had not received the RTI Application and that he was otherwise ready to respond to RTI Applications. In person he submitted that the information sought for relating to BPL Register can now be supplied for the period starting from 2008. He added that he has not been able to locate any BPL related Register pertaining to 2006 and 2007.

Considering the above facts and circumstances, the Commission hereby orders that the Secretary, Ratabari GP will provide the information available with him to the Appellant within a period of 10 days of receipt of this order and also make further endeavour to locate the records relating to 2006 and 2007 as well.

With this the Second appeal is disposed of.

However, the Appellant will be at liberty to approach the Commission, if he is not satisfied with the information provided to him.
