Perused the written submission No. DME/RTI/1152/1012/94 dtd 2.11.2015 made by the Director, Madrassa Education, Assam stating in the WS that prompt action has been taken by that office relating to transfer of the RTI Application to the concerned school namely Madani Nagar Sr. Madrass and directing the school authorities once again on receipt of the First Appeal from the Applicant. It has also been submitted that the school authorities furnished the information to the Applicant on 16.1.13 along with instructions to the Applicant to pay an amount of Rs. 54.00 as cost of photocopying, etc.

The SPIO in the office of the DME, Assam, who was personally present, reiterated the contents of the said WS.

On perusal of the case records also it indicate that the SPIO in the office of the DME, Assam had already instructed the said school authorities to furnish the information on receipt from the Commission a letter from the Applicant through his letter dtd. 22.2.12 that he had paid the above mentioned amount by way of money order, although the said letter of the Applicant is stated to have not been received by DME and there was no evidence of the money having been received.

In view of the above, it is ordered that the Superintendent, Madani Nagar Sr. Madrassa will furnish the remaining information along with related documents free of cost to the Applicant within 15 days of receipt of this order.

With this the Second appeal received from Md Nasir Uddin is disposed of.
