Perused the written submission dtd 20.11.15 submitted by the Deputy Director, Food, Civil Supplies & CA, Barpeta. The Public Authority has submitted that the RTI Application had been transferred promptly to the SPIO & Secretary, Dakshin Gilazari GPSS Ltd. u/s 6(3) of the RTI Act, 2005. Thereafter, on receipt of the First Appeal from the Applicant dtd. 8.5.13, the SPIO & Secretary, Dakshin Ghilazari GPSS Ltd. was requested through a letter dtd 21.5.13 to furnish the information sought for by the Applicant within 10 days.

The SPIO & Secretary Dakshin Ghilazari GPSS Ltd. submitted personally that the Applicant had not responded to the request from his office to collect the information.

Perused the WS made by the Appellant where he has stated that he could not attend the SPIO's office on account of illness and he will attend the office after his recovery and collect the required information/documents personally.

Considering the above facts and circumstances of the case, the Commission hereby orders that the SPIO will provide the information/documents free of cost to the appellant as and when he attends his office.
