The first Appellate Authority/Divisional Officer, Barpepta Soil Conservation Division submitted written statement wherein it has been submitted that the remaining detailed information which the Applicant had sought has been enclosed. The First Appellate Authority further submitted that information and documents related to it are now ready to be provided to the Applicant. The First Appellate Authority has also submitted that the delay in furnishing complete information was not deliberate.

Perused the W.S submitted by the SPIO/Range Officer, Gauripur Soil Conservation Range, Alomganj. The SPIO submitted that the part of the information sought for by the Applicant had not been provided to are now ready to be provided.

The Commission, therefore, considered all the facts and circumstances of the Second Appeal case. It is hereby ordered that the SPIO will make the said information and documents connected therewith furnished to the Appellant Md. Jahijur Abbas as soon as possible, but in any case not later than 10 days from today. As the voluminous enclosures of the WS as mentioned above, would be useful for supply to the Appellant, this may be handed back to the Public Authority with proper acknowledgement. As the remaining information is being furnished to the Appellant as mentioned above, the First Appellate Authority may consider and dispose of the First Appeal with a period of 21 days of receipt of this order.

With this the Second Appeal is disposed of.
