<u>ORDER</u> 26.11.2015

The petitioner, Md Ahmed Hussain as well as the Public Authority represented by the PIO in the office of the Project Director, DRDA, Goalpara – both are absent without information. The Second Appeal petition dtd 31.12.13 is therefore, taken up for consideration ex-parte in the absence of both the parties.

From perusal of the case records it is seen that the Petitioner filed an RTI petition dtd 12.9.13 before the PIO in the office of the PD, DRDA, Goalpara seeking information on implementation of various schemes under Rajmita Gaon Panchayat of Jaleswar Development Block for the period from 2006-07 to 2012-13. The PD's office transferred the RTI petition to Jaleswar Development Block. This was followed up by a First Appeal petition dtd 30.10.13 addressed to the BDO, Jaleswar Development Block and the Second Appeal petition dtd 30.10.13 before this Commission apparently for non-receipt of the required information.

From perusal of the RTI application it is seen that the information sought for are admissible under the RTI Act, 2005. The Commission therefore, directs the BDO, Jaleswar Development Block to allow the Petitioner, if he wants to do so, to inspect relevant documents/ records pertaining to his RTI petition dtd 12.9.13 on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of documents as may be required by him free of cost upto 25 copies and Rs. 2.00 per copy thereafter.

With the above, the Second Appeal petition dtd 31.12.13 is disposed of
