It appears that the First Appeal submitted by the Appellant to the Commissioner & Secretary, Education (Ele) Department, Govt. of Assam has not been disposed as mandated by the RTI Act, 2005. It is hereby ordered that the First Appellate Authority in the office of the Commissioner & Secretary, Education (Ele) Department will consider and dispose of the First Appeal with a speaking order within 21 days from the date of receipt of this order.

Attention of the SPIO is also drawn to the fact that he had neither submitted a WS to the Commission nor appeared before the Commission for the hearing. He is hereby directed that on receipt of hearing notice in RTI Appeal cases in the future, he will either update the Commission by submitting a WS or be present at the hearing to apprise the Commission, the action taken in compliance with the RTI Act, 2005.
